- Created by US Congress under Immigration Act of 1990.

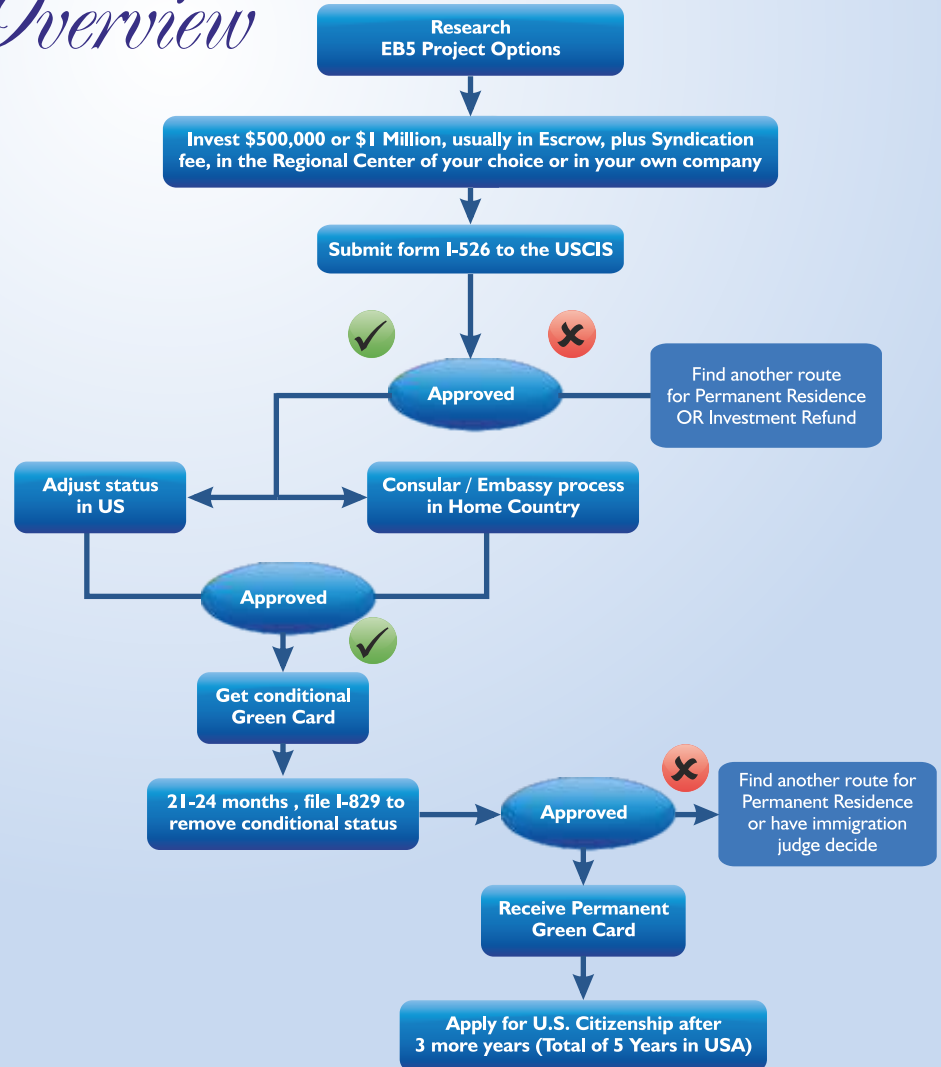
EB-5 Process Overview

The Investor's Eligibility Criteria

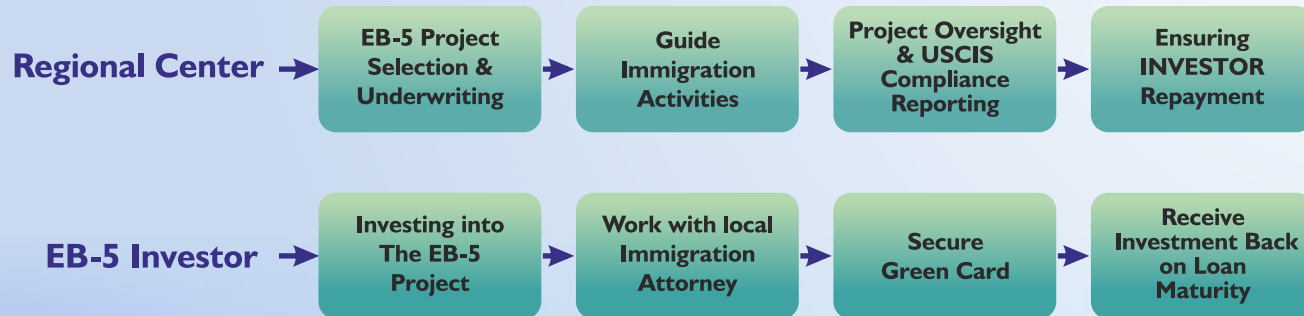
Ability to Invest \$500,000 (for a min of 5 yrs)

Financial : Ability to prove legitimate source of USD \$500,000.

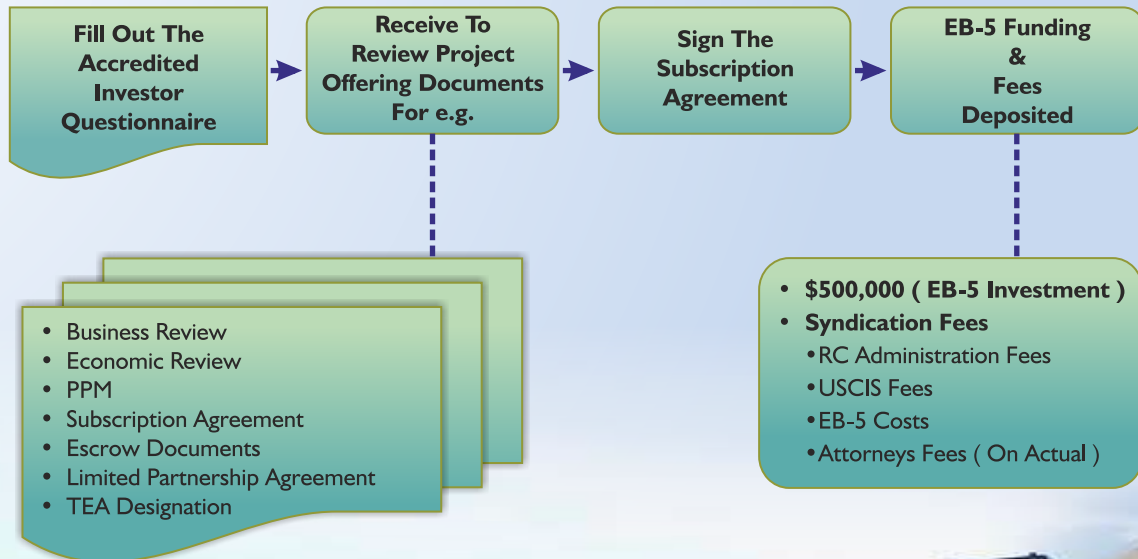
Personal: No problems, i.e. criminal record, etc.
